In the name of the State of Maine, you are hereby required to notify and warn the voters of the Town of Litchfield to meet at the Litchfield Sportsmen's Club on Tuesday, the 11th day of June 2024 A.D. at eight o'clock in the forenoon, then and there to act on the following articles, to wit:

SECTION I - ADMINISTRATION

- Art. 1. To choose a Moderator to preside at said meeting.
- Art. 2. To elect all TOWN OFFICERS required by law and previous vote of the Town to be chosen by secret ballot; namely, Select Board, Litchfield Academy Trustee, RSU4 Board Director, and Budget Committee. The polls will open at eight o'clock in the morning and will close at eight o'clock in the evening. The meeting will then adjourn after the ballots have been tallied and reconvene at the Carrie Ricker School Gymnasium at ten o'clock Saturday morning, June 15th, 2024 A.D.
- Art. 3. To see if the Town will vote to hear and discuss any reports of any Boards, Committees, or Officers of the Town (whether residing in the Town or not).
- Art. 4. To see if the Town will vote to fix Oct. 15, 2024, or up to 30 days after commitment, whichever is later, Jan. 15, 2025, and April 15, 2025 as the dates on each of which one-third of the property taxes are due and payable, and as the dates from which interest will be charged on any unpaid taxes and liens for tax year 2024-25 at the rate of 4.0% per year.

Explanation: Many communities fail to appropriate money to be used to pay abatements granted during that budget period. They simply use the overlay generated through the tax commitment. Even though 36 MRSA. § 710 [see MRSA reference list in Town Report] authorizes assessors to raise overlay, there is no authority to spend the amount of the overlay without a town appropriation vote. In addition to abatements, overlay may be used to cover unexpected expenditures if the contingency fund has been depleted.
